A 5% Bid Bond is required to be submitted with the bid. The successful bidder will be required to furnish a 100% Performance Bond and 100% Payment Bond to cover the execution of the contract which shall be in conformity with the forms of bonds indicated in the Specifications and for the contract amount. The Town of Cape Elizabeth reserves the right to waive all informalities and reject any and all proposals or to accept any proposal.

Minority and Woman Business Enterprises Requirements

Each bidder shall take special notice of the Guidance for use of Minority and Woman Business Enterprises in sub-agreements. Failure to complete the requirements of this program may result in finding that the bidder is non-responsive and therefore, not entitled to award of this contract.
