Hi Maureen. Here is my 5 point list of what I took from the surveys and the public forum. These are what I saw as the town's priorities, as reflected in the public feedback:

1. No major development
2. More small businesses like cafes and restaurants; no multi-family housing
3. Traffic issues (various: slower speed limit, rationalize Shore Rd intersection, traffic calming measures)
4. Do something with the vacant lot next to TH (I know it isn't possible, but it was said so often that it is one of the top 5)
5. Beautify (again, various, from making the strip mall prettier to trees to a village green to signage, etc, all with a common theme of making it more visually appealing)
6. Impeach the TCPC! (couldn't resist)

I also want to pass along that in last night's TML trustee meeting, RuthAnne discussed the results of a survey we distributed on the future of the library. There was a Comments section and she said 80% of them had to do with the library as the center of the town center. Since that hasn't been reflected in our own survey, I asked her to send me the results and I will pass them along to the TCPC (thru you) when I get them.

I also heard recently that there is a group starting up to press for specific Scott Dyer/Shore Rd intersection changes. I don't really have any details other than that it's headed by a former councilor of our acquaintance. If you have any info on that effort can you please pass it along since it might affect or interfere with our own work.
