The regular meeting of the School Board was held on Tuesday, October 8, 2002, at 7:30 p.m. in the Council Chambers.

The meeting was called to order at 7:30 PM by Chairperson Marie Prager.

Items 11b, 11c, 12g and 12f, all dealing with trips with high school students, were moved to come after Item 7, "Recognition".

3. Approval of School Board Minutes

The minutes of the regular meeting held on September 10, 2002 and the special meeting held on September 24, 2002, were approved as presented.

4. Comments by Student Representatives

Hillary W. and Aaron M., the High School representatives to the School Board, reported on items of interest from the students' perspective at the High School.

Elise M. and Elise M. were introduced as the Middle School's representatives to the School Board for the year. They updated the Board on student activities at the Middle School.

5. COMMUNICATIONS

5a. Dr. Forcella pointed out the MSBA Proposed Resolutions were included in their board packet. He asked board members to review them and get back to Susan Steinman with concerns before the meeting in Augusta later in the month.

5b. The Superintendent pointed out that there was a copy of a letter from the Fulbright Memorial Fund Fellowship regarding Principal Tom Eismeier's trip to Japan.

7. RECOGNITION

Kelly Hasson, first grade teacher at Pond Cove School, was presented a certificate in recognition for her accomplishment of being a finalist for the Maine Teacher of the Year sponsored by the State Department of Education.

Kevin Sweeney gave a brief update regarding PATHS and the programs it offers.

9. PRINCIPALS' REPORTS

Jeff Shedd, High School Principal, John Casey, Assistant Principal at the Middle School, and Carmen Melito, Assistant Principal at Pond Cove, reported to the Board on items of interest at their respective schools.

10. SCHOOL BOARD SUBCOMMITTEES AND REPORTS

10a. Finance Subcommittee

Finance Subcommittee Chair Elaine Moloney reported that the subcommittee met prior to the school board meeting where they signed warrants, reviewed appropriations reports, and discussed items including a review of the annual financial report, the format for "Program Costs/Benefit Analysis", and the building project.

10b. Policy Subcommittee

Policy Subcommittee Chairperson Susan Steinman reported that at the October meeting the subcommittee discussed the guidelines and procedures for the iBooks. She explained that these are not policies, but it is important to get School Board input and approval. A copy of the proposed guidelines was included in the board packet for review and will be discussed under "New Business".

10c. Building Advisory Committee

Building Advisory Committee Chairperson Marie Prager reported that the committee met on September 26, 2002 when it focused on a discussion of the options for the High School Renovations Project and developed a number of options for consideration.
