This letter is to notify you that your school has been identified as a Monitor School based on the criteria outlined in Maine's approved accountability system under the Elementary Secondary Education Act of 1965 (ESEA). Priority and Focus Schools have been previously identified and are currently working with an assigned consultant to perform a school wide needs assessment and develop a school improvement plan.
